**SYNOPSIS:**

Report on an assault.

**NARRATIVE:**

On 03/13/17 at approximately 1510 hours I Officer Ryan Mitchell while working for the Stillwater Police Department received a call on an assault report. The complainant was identified as 12 year old . I contacted by phone at his request. stated that he was walking home from school today. He walked from the school located at 523 March Street, being the Stillwater Area Junior High. He stated he walks past the cemetery. He walks southbound on Osgood. stated that he crossed the street on Osgood toward the funeral home. I believed this to be Simonet Funeral Home.

tated that while he was walking a vehicle drove by. stated at first it looked like there were three approximately teenage boys in the vehicle. The vehicle stopped and asked if he wanted a ride. He stated he did not. stated the vehicle continued on and then appeared to have turned around and pulled up next to him again and asked him again if he wanted a ride. He stated that he did not. The vehicle left again. stated again that the vehicle must have turned around or went in some type of a loop and came back again and at that time stated that for no apparent reason and unprovoked several of the teenagers exited the vehicle.

stated that one of them kicked him in the leg. Another one punched him in the abdomen or rib area and at some point during this physical altercation another one punched him in what described as an upper-cut under his jaw or chin. stated that at that time an older man was driving by and stopped and deescalated the physical altercation. stated at that time the teenage boy (which now appeared to be five of them) got back into their vehicle and drove away and stated that the old gentleman gave ride to his residence at

I then spoke with mother by phone I asked what her thoughts about the incident were. stated that she was just happy that was now home safely. I asked if there are any visible injuries or sign of an altercation or sign of physical altercation or kind of evidence what so ever. She stated that because the incident just recently happened that there is no apparent bruising but she will be watching to see if there are any bruises that appear. I asked about the upper cut and if there was any injuries from that. She stated that there were not. I asked if her son was able to give any kind of description or the teenage boys or the vehicle or a license plate or any identifying information. She stated that there was no identifying information available that she was aware of. I also asked this if he had any type of physical description or vehicle description. He stated he did not.

I asked ~~what her intentions were or what she would like to see done specifically at this time being the fact that identification might be extremely difficult with the limited information that we have.~~ She stated at this time that she wanted to make the police department aware. I also advised that on Tuesday March 14th the School Resource Officer Austin Peterson would be in the office and available to speak to further regarding this incident in case there is any recommendation or information that he may also have for her. ~~stated that she would make contact with Officer Peterson on Tuesday and go from there.~~

On Tuesday March 14th I did touch base with Officer Peterson and he stated that he had received the information and was working with the school administration regarding this incident.

CONCLUSION:
